3.01 PURPOSE. The purpose of this ordinance is to establish County Supervisor Districts and Election Precincts as the result of the population changes reflected by the 2010 Federal Census, in accordance with Iowa Code Sections 49.7 and 331.210A.

3.02 LEGAL DESCRIPTION OF DISTRICTS:

District #1-Population 22,250 shall encompass the following:

Dallas twp., city of Dawson, Spring Valley twp., city of Perry, Beaver twp., city of Bouton, Des Moines twp., city of Woodward, Lincoln twp., Washington twp., Grant twp., city of Granger, city of Grimes, Linn twp., city of Linden, that portion of Walnut twp. lying east of X Avenue, city of Urbandale, Union twp., city of Dexter, and city of Redfield.

District #2-Population 21,976 shall encompass the following:

Sugar Grove twp., city of Dallas Center, city of Minburn, that portion of Adel twp. not contained in District #3, that portion of Walnut twp. not contained in District #1, city of Clive, and city of Waukee.

District #3-Population 21,909 shall encompass the following:

Colfax twp., city of Adel, that portion of Adel twp. lying south of the city of Adel not contiguous to the remainder of Adel twp., Adams twp., city of DeSoto, Van Meter twp., city of Van Meter, Boone twp., and city of West Des Moines.

3.03 LEGAL DESCRIPTION OF PRECINCTS:

All voting precincts for the cities of Adel, Clive, Perry, Urbandale, Waukee, and West Des Moines shall be established by ordinance by their respective City Councils. All remaining voting precincts (including city of Grimes, as stated in a memorandum of agreement) shall be designated as follows:

3.04 AGREEMENTS: Dallas County has entered into Memorandums of Agreement with the cities of Adel, Clive, Grimes, Waukee, and West Des Moines whereby residents of unincorporated areas and residents of a city share a precinct. The boundaries of the combined precincts for the cities of Adel, Clive, Waukee, and West Des Moines shall be established by ordinance by their respective City Councils. The boundaries of the combined precinct for the city of Grimes is established by the County by ordinance. The territory included in each agreement is as follows:

Waukee	That portion of Boone Twp. lying north of Interstate 80 and that portion of Boone Twp. lying south of Interstate 80, west of Ute Avenue, and north of 360 <sup>th</sup> Street.	Waukee 5 and Waukee 6

3.05 REPEALER: All ordinances or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

3.06 SEVERABILITY: If any section, provision or part of this ordinance is adjudged invalid or unconstitutional, such adjudication will not affect the validity of the Code of Ordinances as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

3.07 EFFECTIVE DATE: This ordinance shall be in full force and effect on January 15, 2012 after its passage, adoption, and publication as required by law.
